2. **DIENSTE AANGEBIED:**

3. **BETALING:**

**1. EFFECTIVE DATE AND TERM:**

This agreement will be effective from first school day of 2025: **15 January 2025** or any said date concurred in writing by the parties concerned (the "Effective Date") and is applicable to the last school day of 2025: 10 December 2025 subject to termination of point 5 as mentioned below.

2. **SERVICES RENDERED:**

Hendrik Louw Aftercare offers services to the learner/s from 12:30 to 14:15 on weekdays: Mondays to Fridays only during school terms, excluding all school holidays and public holidays from the "Effective Date" and for the duration of the agreement.

3. **PAYMENT:**

In exchange for the services rendered by Hendrik Louw Aftercare from and after the Effective Date, and for as long as this agreement is valid, the parent/s pay Hendrik Louw Aftercare **R470 pm** for a period of 11 months before or on the 1<sup>st</sup> of every month. Aftercare payments are payable in advance, together with school fee payment. The last payment is to be paid on/before 1 November 2025. **Parents hereby agree to ensure that their school accounts are always up to date and understand that if their school account is unpaid on any occasion the learner will not be allowed to attend aftercare until such time as school account is brought up to date in full.**

The parties further agree that in the case of late payment, regarding the dates as set out above, a fine of R30-00 PER DAY will be levied, which will need to be paid together with the outstanding payment for the said month in order to allow resuming aftercare attendance.

4. **ACCOUNTABILITY:**

The above-mentioned and undersigned parent/s agree and undertake to safeguard Hendrik Louw Aftercare and the staff of the aftercare as well as Hendrik Louw Primary School regarding all and any accountability and with regard to all and any actions, procedures, claims, damages, rent, costs and expenses because of physical damages / injuries of whatever nature sustained by the child unless caused by gross negligence on the part of Hendrik Louw Aftercare, aftercare staff and Hendrik Louw Primary School.

5. **TERMINATION:**

Any of the two parties concerned may terminate this agreement with or without reason, with 1 month prior written notice to the other party.

6. **DOMICILIUM:**

The parties further choose their respective domicilia citandi et executandi from the addresses that appear under their names at the salutation of this agreement, for the purposes of the agreement as well as for any legal action (including legal documentation such as a summons) that may emanate from this agreement.
